

ES Series Mobile End of Life Announcement

Effective Release: 10/01/16

With the introduction of the Viking series mobile portfolio and its continuous new product introductions and enhancements, EFJohnson is announcing the end-of-life of its ES series **mobile** radios. The Viking mobile platform is a replacement for the ES series mobile radio platform with several new features and enhancements.

The following models are discontinued effective on the dates indicated in Table 1:

Note: Ascend ES mobile (700/800MHz) with Part Number 242-557x-xxx-xxxx6 targeted at Multi-Net customers was already discontinued as part of the Multi-Net End of Life announcements and will also remain discontinued per timelines for the Multi-Net EOL announced earlier.

End-of-Life Announcement Date	The date the announcement for the end-of-life of a product is distributed to the general public.	October 1, 2016
End-of-Sale Date	The last date which EFJohnson will accept a purchase order for the specific product. The product is no longer for sale after this date.	Earlier of March 15, 2017 or while inventory supply exists. *Must ship no later than March 31, 2017.
End of SW Maintenance Releases Date	The last date that EFJohnson may release any final software maintenance releases or bug fixes. After this date, EFJohnson will no longer develop, repair, maintain, or test the product software.	October 1, 2017
Last Date of General Support	The last date to receive applicable service and support for the product not under service contracts or by warranty terms and conditions.	October 1, 2022
Last Date of Contractual Support	The last date to receive applicable service and support for the product as entitled by active service contracts or by warranty terms and conditions. After this date, all support services for the product are unavailable, and the product becomes obsolete.	Later date of "Last Date of General Support" or per contractual terms.
